

**AMENDMENT TO INTERGOVERNMENTAL COOPERATION AGREEMENT  
BETWEEN THE TOWN OF MIDDLETON AND THE CITY OF MIDDLETON**

THIS AMENDMENT to Intergovernmental Cooperation Agreement between the Town of Middleton and the City of Middleton (“Amendment”) is entered into and made effective this 3rd day of March, 2025 (“Effective Date”) by and between the Town of Middleton, a Wisconsin body corporate and politic (“Town”), and the City of Middleton, a Wisconsin municipal corporation (“City”).

**RECITALS**

WHEREAS, Town and City entered into that certain Intergovernmental Cooperation Agreement between the Town of Middleton and the City of Middleton, dated May 12, 1994 (“Agreement”), which provided, among other terms and provisions, that the Agreement applies to certain governmental actions taken during a period of twenty (20) years commencing on the date of the Agreement; and

WHEREAS, the Agreement automatically renewed for an additional period of ten (10) years at the end of the original term unless either party thereto notified the other party in writing, at least one (1) year prior to the expiration of the original term of the Agreement, of its intention not to renew; and

WHEREAS, neither party to the Agreement gave timely written notice of non-renewal to the other party hereto, and the original term of the Agreement was, therefore, extended to and including May 12, 2024; and

WHEREAS, the parties hereto have entered into a written agreement between and among them providing that the term of the Agreement shall be extended for a period of one (1) year to and including May 12, 2025; and

WHEREAS, the parties hereto desire to enter into a written agreement between and among them providing that the term of the Agreement shall be further extended for a period of one (1) additional year to and included May 12, 2026;

**AGREEMENT**

Now therefore, for and in consideration of the mutual promises set forth herein and for other good and valuable consideration, the Town and the City do hereby agree as follows:

1. The parties hereto have agreed to extend the term of the Agreement for one (1) additional year to and including May 12, 2026.

2. The parties hereto further agree that all of the other terms and provisions of the Agreement shall be and remain in full force and effect, without change, except as amended herein. This Amendment and the Agreement, as amended herein, may be amended or modified only by a written instrument authorized by the Town Board of the Town and by the Common Council of the City.
